## Pre-meeting presentation and discussion: Human Rights City

Adele Dunstan from Swansea Council presented on the background and priorities of the Swansea Human Rights City initiative – a priority of Swansea PSB, Swansea Council and other partners. She pointed out that Swansea is only the second city in the UK to declare their commitment – the UN scheme has no accreditation system and requires self-declaration. Adele explained that the current five priorities were chosen following an extensive public survey undertaken last year. She also outlined achievements so far (e.g. publication of pocket guide, delivery of training) and the process to develop a five-year action plan (PSB partners are also expected to develop their own plans).

It was suggested that the two HRC priorities most relevant to SEF are 'Tackling Poverty' and 'Human Rights Awareness' and there followed a lively discussion with those present on these and championing of environmental rights. The discussion included the following key queries, comments and suggestions:

- Concern about level of understanding about difference between poverty and depravation. Decades of focus on mitigating depravation but not addressing causes of poverty.
- Access to green space issue should not be about taking those deprived of it to the countryside but about building green spaces and nature into urban areas
- Poorer people are not responsible for causing climate change but will be most impacted.
- Concern that the HRC project so far had involved lots of talking and publications but not really practical action on the ground.
- UN formal declaration of environmental rights in 2022 should be incorporated into future training programmes and awareness activities.
- Needs to be links between the priorities and not tackled in silos.
- Tended to be a focus on short-term steps to ease levels of depravation to make lives easier. PSB was set up to take a longer-term focus.
- Nature Conservation is mapping biodiversity, green space, environmental quality at ward level – agreed to meet with Adele to discuss further.
- Who will deliver action plan? During process, action leads will be identified. Action plan will be SMART.
- Still lack of understanding of what human rights are.
- There are limited powers at a local level to change things.
- In the initial survey to determine the priorities, young people chose environment / climate change as their top priority should this have been included as a priority?
